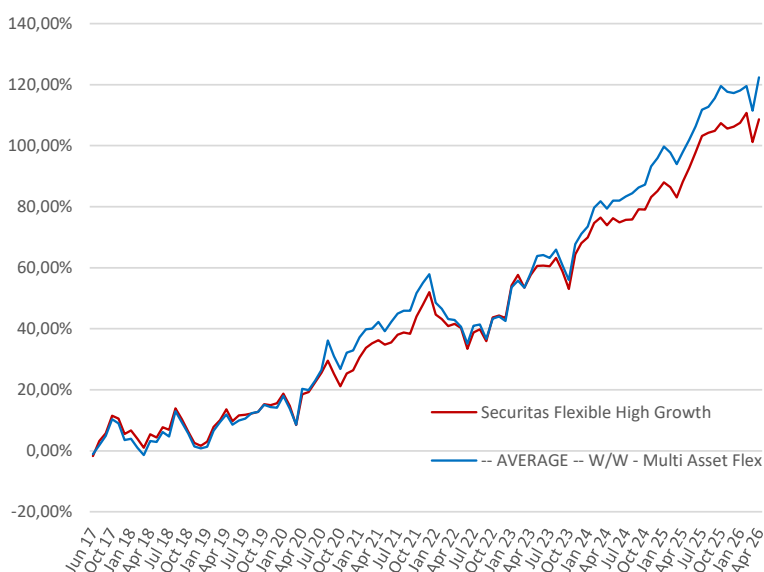


INVESTMENT OBJECTIVES

The portfolio aims to create long-term wealth for investors. The portfolio aims to outperform the average return of the sector and achieve a return in excess of CPI + 5% over a rolling 5 to 7-year period.
